Music Release Form Letter of Agreement [see also Appendix A overleaf]

I/We are granting the GULF ISLANDS FILM & TELEVISION SCHOOL (herein referred to as GIFTS) the right to include the music specified in "Appendix A" in their music/sound library, which the students will draw upon for use in the videos they create while attending the GIFTS video production program. I/We understand that the final video projects will be used for non-commercial purposes which shall include, but not be limited to, festival screenings, screenings at educational institutions, archiving and broadcasting (on television, cable, Internet, etc.)

GIFTS retains non-exclusive broadcast rights which are shared with students. Students have the right to distribute productions independently, but must notify GIFTS of any commercial distribution.

In consideration of the grant of these rights, GIFTS will properly credit the musicians for music used in the videos. GIFTS has agreed to notify me/us in the event of any commercial broadcast.

Finally, I/We understand that GIFTS will remit any net profits from the distribution of GIFTS productions to the Access to Media Education Society, for the sole purpose of providing bursaries to students who cannot otherwise afford to attend GIFTS or any of its programs.
